## Underwriting Requirements\*

- Minimum of 3 years in business or equivalent management experience
- If no prior coverage, no less than 5% scheduled debit 1st year
- Undeveloped loss ratio of 50% or lower current and prior 2 years
- Experience rated accounts up to 1.40 modification factor
- Governing class code Hazard Group A, B, C, D, and/or E

- Minimum \$50,000 WC premium with no max
- 75% of gross receipts from trucking operations

## SUBMISSION REQUIREMENTS

- ACORD Application
- Supplemental applications as required by underwriting
- Current and prior year experience mod worksheet
- Premium and payroll (if available) for preceding 5 years
- 5-year currently valued loss runs including claim descriptions
- First agent submitting complete request is protected
